2. **Administrative Matters**

2.1 There have been three meetings of the SACRE in the academic year 2014 / 2015 since the last report. Minutes of all the meetings are available on application to the Clerk, Democratic Services, Telford & Wrekin Council, Addenbrooke House, Telford (phil.smith@telford.gov.uk). Meetings are open to the public.

2.2 RE resources and multi-cultural resources are still sited at Hollinswood Primary and RE network meetings and SACRE meetings still held there. Our thanks to the school for their hospitality.

3. **RE advisory support**

3.1 **Joan Furlong** 's contract as Telford & Wrekin RE consultant for the academic year was for 5 days. She is able to be contacted by email or phone for individual school support. Her details are on the Learning Platform.

3.2 The main event of the year was the launch of the new **primary scheme of learning**, written by Lat Blaylock of RE Today services. The launch was held at Hollinswood Primary on 11th September at 5pm, followed by SACRE. The Mayor was present and presentations made. It was a joyful celebration of RE. Via a video link Lat explained the scheme of learning for teachers – 40 Primary schools attended and received their discs (Other discs sent by post). This was a massive achievement, made possible by the LA. Our thanks to Jim Collins for the funding. All T&W Primary & Special schools now have the best quality planning & assessment for RE.

RE's place in the primary curriculum is secure.

3.3 **The Primary RE network** has met twice during the year – Autumn & Summer terms.

1) The new planning was scrutinized and applauded. Additionally teachers wanted planning for Christmas throughout each year group (R-6). Resources for Easter, Pentecost and Trinity were also asked for – to be delivered mainly in Assembly and Worship. 16 schools attended.

2) Joan Furlong provided resources for the main Christian festivals. These were discussed & applauded. 14 schools attended.

3.4. Joan Furlong spoke at the primary headteachers' forum Sept 25th about the new scheme of learning. 20 headteachers were present.

3.5. Joan Furlong carried out RE consultations at The Bridge school, Apley Wood Primary and William Reynolds Primary.

3.6 **Prayer Spaces in schools**

This initiative in secondary schools continues to make a contribution to SMSC- Spiritual, moral, social, cultural development. Two talented teams of volunteers are providing this experience at Hadley Learning Centre, Burton Borough, Newport Girls Academy and Adams Academy.

Annual training courses have been held at Admaston House for teachers – run by the ‘Prayer Spaces’ and ‘Sacred Spaces’ in schools teams. Other academies are interested in implementing this.

- 3.7 **One Bright Week** was a yr 5 activity day held in 4 churches in Telford. Christianity was explored in line with core questions in the Agreed Syllabus. 11 primary schools attended for a day – each walking to their nearest venue.
- 3.8 Phoenix Academy RE day – a new initiative for year 7 pupils exploring religion through multi-media resources in workgroups – e.g. an inter-faith panel discussing pupils’ questions, a Prayer Space, Religion in Art and film.
- 3.9 **Secondary RE results**
We congratulate schools on their results.
- 3.10 Schools continue to support the work of the **Inter-faith group & Telford Christian Council**. The Holocaust memorial service was noted as a very special spiritual event.
- 3.11 We congratulate Fiona Sargesson-Jones from Dothill Primary on her **Farmington Fellowship**.

4. The Policy Framework

- 4.1 RE – National guidance is available on the Learning Platform.
- 4.2 The Agreed Syllabus 2009 for RE is still providing the legal requirements for the subject. The supporting papers on Assessment in RE (Joan Furlong 2010) RE & Community Cohesion (Joan Furlong 2011) and Teaching Christian Beliefs in RE and the core beliefs of the other 5 world religions (Joan Furlong 2012) are well used. More modern planning is now available in the **new scheme of learning for primary and special schools**(Lat Blaylock Sept 14). Website material forms an important resource for the subject, particularly RE Today Services and Barnabas for schools (Christianity)
- 4.3. Collective Worship
No evidence is available for community schools in Telford & Wrekin. Church schools are monitored through their 5 yearly SIAMS inspection. Joan Furlong wrote Collective worship guidelines (May 13) for all T&W schools. These restate legal requirements and contain a rationale for good practice (to be found on the Learning Platform)
