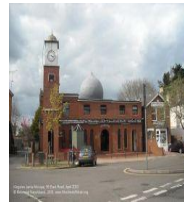
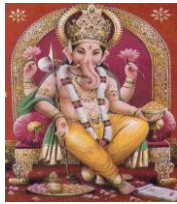

## INTRODUCTION BY THE CHAIR OF THE SACRE, MARIA JAMES

Once again it has been the privilege of Kingston's SACRE to guide and oversee schools with regard to Religious Education (RE) and Collective Worship. We continue to work with Keith Field, our Advisor, who continues to do some excellent work with the Primary teachers. Throughout the year, RE has been the subject of BBC news, so that the current wave of reports on aspects of RE and the place of religious faith has gained national interest.

Earlier this year, Ofsted published **Religious Education: realising the potential** (October 2013), reporting that many, both in education and faith communities, believe that RE is not in a good place. It asserts that changes in education policy, such as the introduction in 2010 of the English Baccalaureate, have led to a decline in RE provision in some if not many schools. The Ofsted report spells out key issues found during visits to 90 primary and secondary schools. One pertinent finding was that the teaching of RE in primary schools was not good enough, because access to high quality RE training for teachers was poor. As a teacher-educator at University, this causes me great concern and I am resolved to do all I can to combat this. This, plus a weakness in teachers' understanding of RE, resulting in achievement and teaching being less than good in 60% of schools visited. It appears the subject has become marginalised and isolated from the rest of the primary curriculum. However, those many teachers within the Borough who realise the importance and value of the subject, have continued to teach the subject with enthusiasm, relevance and rigour and SACRE is pleased and privileged to support their work.

The report also maintained that the quality of RE in secondary schools was equally worrying. The quality of teaching was rarely outstanding and less than good in around half the lessons they observed. There is also a weakness in examination provision at KS4. The Religious Education Council (REC) launched their Review of RE on 23 October at the House of Commons, hosted by Stephan Lloyd MP, Chair of the All Party Parliamentary Group on RE. The report contains a new **Curriculum Framework for RE**, parallel to the new National Curriculum subject frameworks, which schools are preparing to teach from September 2014. A downloadable copy of the Review report is available on the REC website, in both the full version and a short version which contains the RE curriculum framework on its own. An encouraging feature of the report is that its Foreword has been signed by Michael Gove, who admitted in July that he had perhaps been guilty of 'neglecting' RE. The REC are hopeful that his willingness to endorse their Review implies that he perhaps may do more to support the subject. This is certainly the hope of Kingston's SACRE.

The RE Curriculum Framework outlines the purpose of RE, its aims and breadth. It contains programmes of study for three Key Stages as well as guidance on RE in the Early Years and beyond 14. In addition, a second part of the report covers current issues that shape RE's context and makes recommendations for taking these forward, including improving training and resourcing. The report, which was fully agreed by the REC Board, also has the support of the major faith communities, RE professional groups, as well as the Department for Education – in itself a first and seen as a major step forward. The REC believes that the Review will provide an agency for working with the Department and others on curriculum development, assessment, qualifications reform and training.

The new framework has some key areas of study which have been written to encourage the students' own enquiries as they look at subjects such as ancient wisdom and scripture, community, encountering people and places of faith. Following the launch, there are to be five regional dissemination meetings: these are free and open to all on a first come first served basis. Details are on their website.

As Chair of Kingston's SACRE, I know how dedicated and careful the various members and local government officers are about supporting the RE of this borough. Throughout the year we are glad to welcome new members but sad to say farewell to others and this year we lost Sam Mitchell and Heather Henderson – their service to SACRE and their wisdom will be sorely missed. As ever, we applaud the excellent practice in our schools. At a time of continual change and perception, SACRE members look forward to another year of serving the hard-working teachers of our Borough, counting it a privilege to be involved in this ongoing service.

My particular thanks again go to Mrs Maria James for chairing SACRE throughout the year. I also wish to offer her my congratulations on the successful completion of her doctorate, the writing of which will no doubt add to the already considerable knowledge and experience she brings to her role as Chair.

I am glad to see that our SACRE was represented at the National Association of SACRE's AGM and through the work of our Consultant RE Advisor, Mr Keith Field, SACRE is kept abreast of current developments in the RE world.

My Directorate continues to coordinate the work of statutory and voluntary agencies in the borough to promote the education and welfare of all our children and young people. 2012 has been an interesting year for RE with the first major investigation by the All-Party Parliamentary Group on RE and the Religious Education Council's subject review, running in parallel with the DfE review of the National Curriculum and I remain very aware of the crucial role that SACRE, the Inter-Faith Forum and our local faith communities play in both nurturing and providing development opportunities for our young people within a variety of cultural traditions.

I wish the members of SACRE every success in their ongoing work at this challenging time, as we seek to work together for the well-being of our children and young people.

## **OFSTED REPORTS**

At every meeting SACRE members review the grading schools have received from Ofsted. SACRE Members recognise that it is now extremely difficult for schools to achieve outstanding.

## **SIAS REPORTS**

SACRE Members also reviewed the excellent SIAS Reports received by Christ Church C of E Primary School, New Malden and St Andrew's and St Mark's C of E Junior School. Both the schools received outstanding reports and were excellent examples of how RE is taught.

## **RE QUALITY MARK**

The RE Quality Mark has three levels – gold, silver and bronze. Schools have to decide what level they want to apply for. The Quality Mark lasts for three years. It costs £400 to apply for the Quality Mark and schools can apply to SACRE for help with funding to subsidise their application. SACRE is currently reviewing the criteria to agree to support a school. Please contact the SACRE Clerk if you wish to make an application for funding for the Quality Mark.

## **QUESTIONNAIRE TO SCHOOLS**

SACRE members would like to thank every school that completed the questionnaire. 24 schools responded to the questionnaire which showed that RE is well resourced in Kingston schools. The majority of schools also felt that their RE teaching and pupils' achievement in RE was good or outstanding.

## **ALL PARTY PARLIAMENTARY GROUP (APPG) ON RE**

An All Party Parliamentary Group was established to look at RE teaching due to the concerns that RE was being taught by Teaching Assistants. 300 primary schools participated in this review of RE teaching and it was found that in 25% of primary schools RE is taught by a Teaching Assistant. There is also a lack of confidence in primary school teachers about teaching RE and teachers have inadequate access to training.

The APPG is recommending that local authorities ensure sufficient resources are made available to enable SACRE's to provide high quality RE support for schools and the monitor the quality of provision and staffing in schools.

## **THE RELIGIOUS EDUCATION COUNCIL REVIEW OF RELIGIOUS EDUCATION**

Under the present coalition government, an extensive review of the National Curriculum is taking place. As changes in curriculum and assessment arrangements for other subjects have implications for Religious Education, this provides an opportunity to clarify RE's distinctive place within the wider school curriculum. As part of its Strategic Plan, the RE Council (REC) has undertaken to carry out a review of RE, following a similar pattern to that adopted by the National Curriculum Review.

There were four areas of focus for Phase 1 of the review:

- Focus 1        The Aims of RE
- Focus 2        The RE Curriculum
- Focus 3        Exemplification of Good RE
- Focus 4        Assessment (including Qualifications)

Phase 1 of the review took place between May and December 2012. Phase 2 built on this and produced a draft programme of study for RE, which was sent out for public consultation during July and August 2013. In Phase 2 Lat Blaylock and Barbara Wintersgill have been working since the summer on drawing together all the review's recommendations along with the 2013 OFSTED RE Report and the outcomes on the APPG Inquiry on RE. Phase 4 will be the launch of the final report documentation which will be through a series of events around the country during October and November, starting in London on 23 October 2013.

Whilst this will not be a statutory document, its recommendations are likely to be highly influential in the direction RE takes over the coming years.
