#### **Religious Education**

The locally agreed syllabus is Wirral Syllabus. This has been adopted by our maintained schools to be implemented by Sept 2021. Best practice has been shared during RE Network meetings which would suggest the new syllabus is working well and standards of high in our schools. Standards and monitoring of RE in schools has been completed through our recent Ofsted inspections. Most schools have maintained their Good status, one school has moved from Inadequate to Good and one from Inadequate to Requires Improvement. Vulnerable schools continue to have school leadership support funded by the LA. This also ensures standards improve and are monitored each half term. As there are no GCSE results for RE in the last academic year, it is not possible to report on them in this report. The number of schools Good or Outstanding is 88% in the primary sector which is 2% above the national figure of 86%.

Layla Taylor supports the RE subject leaders with regular meetings and advice. She has shared multiple teaching resources and assessment tools to support with the new syllabus.

The work of SACRE has been brought to the attention of the schools governing bodies to ensure they are aware of their statutory duties around RE and collective worship.

There has been no issues or complaints regarding RE education this academic year.



#### **Collective Worship**

The expectation is in line with the Guidance for Collective Worship in schools January 1994, to provide daily collective worship opportunities. During the pandemic, schools have moved to class worship, some schools have returned to full school worship or key stage worship, in incidents of increased covid cases, this is one protective factor that is considered and schools are advised that they will return to small group worship. However, collective worship must still take place. Schools have not narrowed their curriculum which has been acknowledged in recent Ofsted and link officer visits. The Early Careers Framework which has been implemented in Knowsley this year provides new teachers and training teachers with appropriate support and guidance around RE and collective worship. This is being delivered by Best Practice in Knowsley which is one of the approved DFE bodies.

There has been no determinations or issues around collective worship in our schools this academic year.

#### **National Bodies**

3 members of SACRE attended the NASACRE conference in May 2021. This had led to direct work around the RE Quality Mark. We have also used the new annual report template for this report following advice from NASACRE. Knowsley SACRE also hopes to explore links with North West forum for small SACREs in the hope that they can assist in increasing our membership and give further support and guidance.

#### Local Bodies and involvement locally

The two education improvement officers and Chair of Knowsley SACRE Cllr Harvey have close links with all schools across the borough as well as with the local police. In our work we work closely to a range of agencies such as YOS, Police, health, parent carer voice on a range of issues encouraging equality and diversity and the sharing of best practice across these organisations. Our academy chains and our voluntary aided schools take part in our link officer meetings, headteacher briefings and vulnerable schools reviews where necessary so they are also kept up to date with the work of SACRE. Governors have been reminded of the work of SACRE through their Governor newsletter and Chair Of Governors forum this term.

#### **SACRE Arrangements**

Knowsley SACRE will continue to use the communication tools such as headteacher briefings and Governor newsletter to highlight and share their work amongst the school and community. The LA provides clerking for SACRE and funding for our LA advisor. The LA also provides time of two education improvement officers to attend and organise SACRE meetings and agendas alongside the Chair. Funding for SACRE is set aside in the education budget should further training or development plans require its use.
