## **1. Introduction**

### **Function**

Under the terms of the 1988 Education Reform Act, all local authorities are required to maintain a SACRE – a permanent body to provide advice on matters connected with religious education in its area. The SACRE convenes an Agreed Syllabus Conference (ASC) in a 5 year cycle to review and revise the local agreed syllabus for religious education. The local agreed syllabus was revised during 2015-2016 academic year.

### **Governance and structure**

The structure of the SACRE is determined by legislation and comprises of four groups, or committees. The local authority, in consultation with local organisations and faith groups, shapes the membership of the SACRE to ensure it appropriately reflects faith communities in the local authority area. Additional non-voting members can be co-opted by the SACRE to provide specific expertise when required, so the membership can change over time. The governance of the SACRE is determined by a constitution and a code of conduct. Each meeting of the SACRE is led by the Chair or Vice-chair. For a SACRE meeting to be quorate one person from each group must be present. The current membership of the groups is shown at Appendix 1.

## **2. Activities**

### **Meetings**

The SACRE held four formal meetings during the 2015 - 2016 academic year, in September and November 2015 and January and May 2016.

### **Agreed syllabus**

Throughout the year, the SACRE reported regularly to the local authority on progress of the local syllabus review. The principal advice given to the authority was to continue to work in partnership with the three other Humber authorities – North Lincolnshire, Hull and East Riding – to complete the review and revision of the syllabus, working towards a publication date of March 2016. On the SACRE's advice, the local authority continued to agree to contribute to the funding of representatives to work on both the Agreed Syllabus Consultation Management Group and a Regional Working Group leading on the re-write of the syllabus content. It was also agreed that all four authorities would continue funding the establishment of a joint website, accessible to all authority schools, where the agreed syllabus and supporting documents would be hosted. This work was completed and a website hosting the Agreed Syllabus was formally launched at the start of September 2016.

### **Development plan**

The committee continued to advise the local authority on a local development plan. NASACRE recommends the use of the RE evaluation tool to determine the current effectiveness of the SACRE. A number of areas for development were identified:

- Training and support for SACRE members
- Ensure SACRE's work is closely linked to wider local authority plans
- Improve local authority representation on the SACRE
- Increase information to the SACRE on the quality and provision of RE and collective worship in local schools
- Strengthen links with local faith groups
- Increase opportunities for SACRE to hear views and experience of pupils and parents about RE

### **3. Governance and structure**

In November 2015, elections were held for the position of Chair and Vice Chair. Katherine Bruning and Rosalind Smith were nominated and subsequently elected to the respective positions.

SACRE advised the local authority on revising the SACRE constitution and the code of conduct. The revised constitution and code and conduct were submitted to the local authority and approved in January 2016.

The local authority continued to support the SACRE with a link advisory officer from the School Improvement Service and a clerk to carry out administrative functions, including the recording of meetings both of which were provided by the local authority's strategic partner for school improvement. In April 2016, responsibility for this advisory officer role passed from the School Improvement Service to the local authority's Head of Education Services on the termination of the former strategic partner contract. Responsibility for the clerk's role also changed to the local authority's Leadership Teams personal assistant's team.

All agendas and minutes of meetings as well as annual reports are published on the local authority's website.

The SACRE is a subscription member of NASACRE, with all advisory documents and newsletters shared with members.

#### **Training for schools**

As part of its work on the revision of the agreed syllabus, SACRE continued to include schools in consultation on content and assessment. A training event on using the new agreed syllabus was held in July 2016 and attended by approximately 20 RE coordinators from across the area.

Schools were advised of regional and national events.

#### **Contribution of SACRE to the wider local authority agenda**

SACRE ran RE Co-ordinator network meetings throughout the year, visiting local places of worship to strengthen links with faith groups and ensure co-ordinators and teachers are familiar with places of worship in their local community. Network meetings were hosted by both the Grimsby Minster and the local synagogue.

#### **Standards and quality of provision of RE**

All ten secondary schools, a high percentage of primary schools, both special schools and pupil referral units are academies, with an associated reduction in local authority responsibility. SACRE members expressed concern that some secondary academies are no longer offering RE as a discrete subject.

#### **4. Public examinations**
